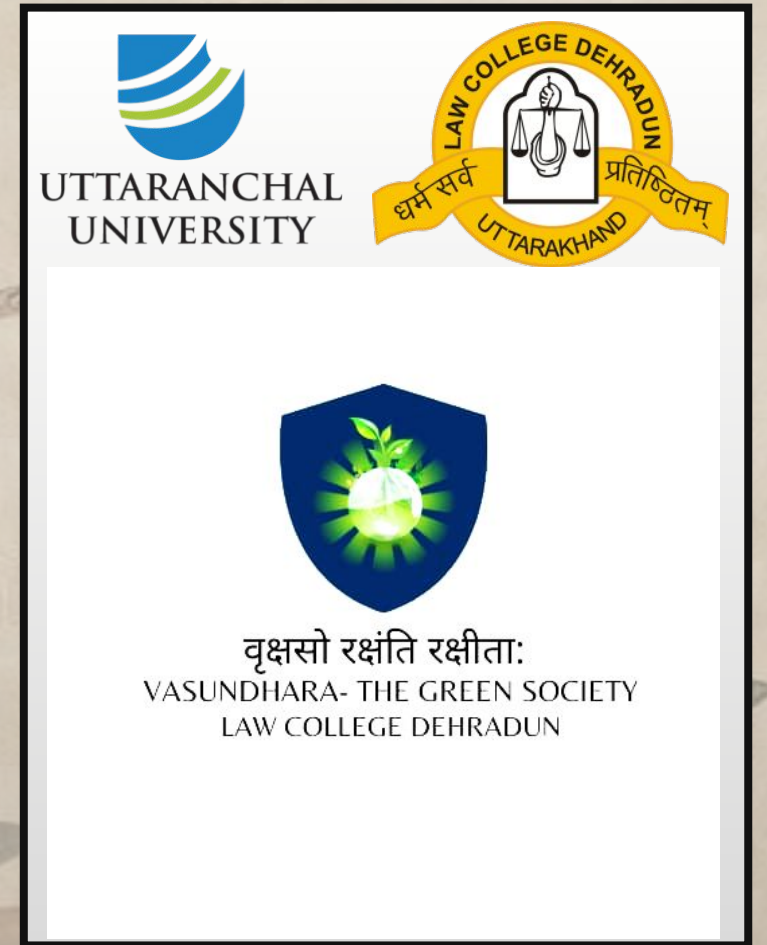

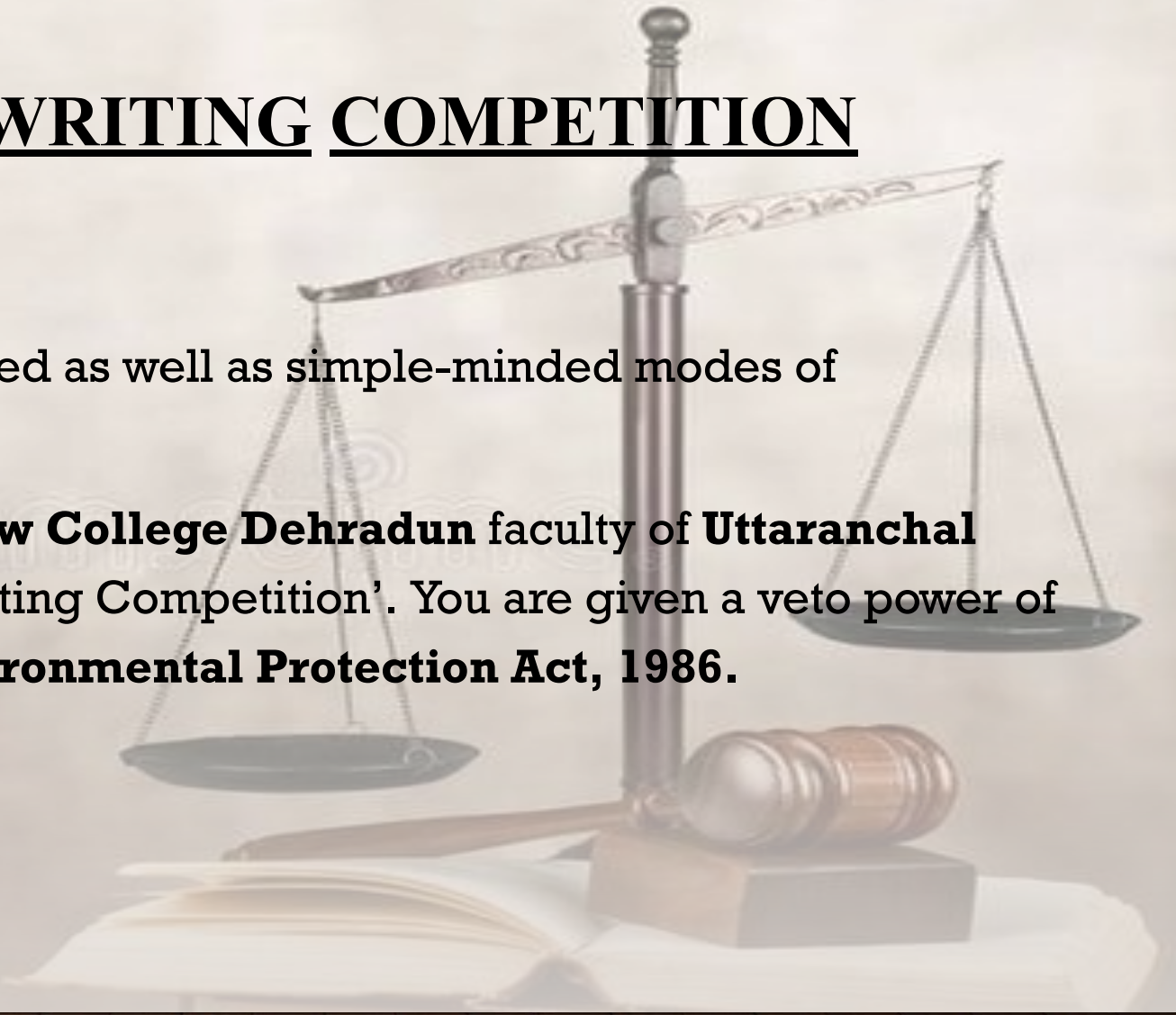
VASUNDHARA-THE GREEN SOCIETY

After the successful submission of the Document, all the participants would be awarded **‘Certificate of Participation’**

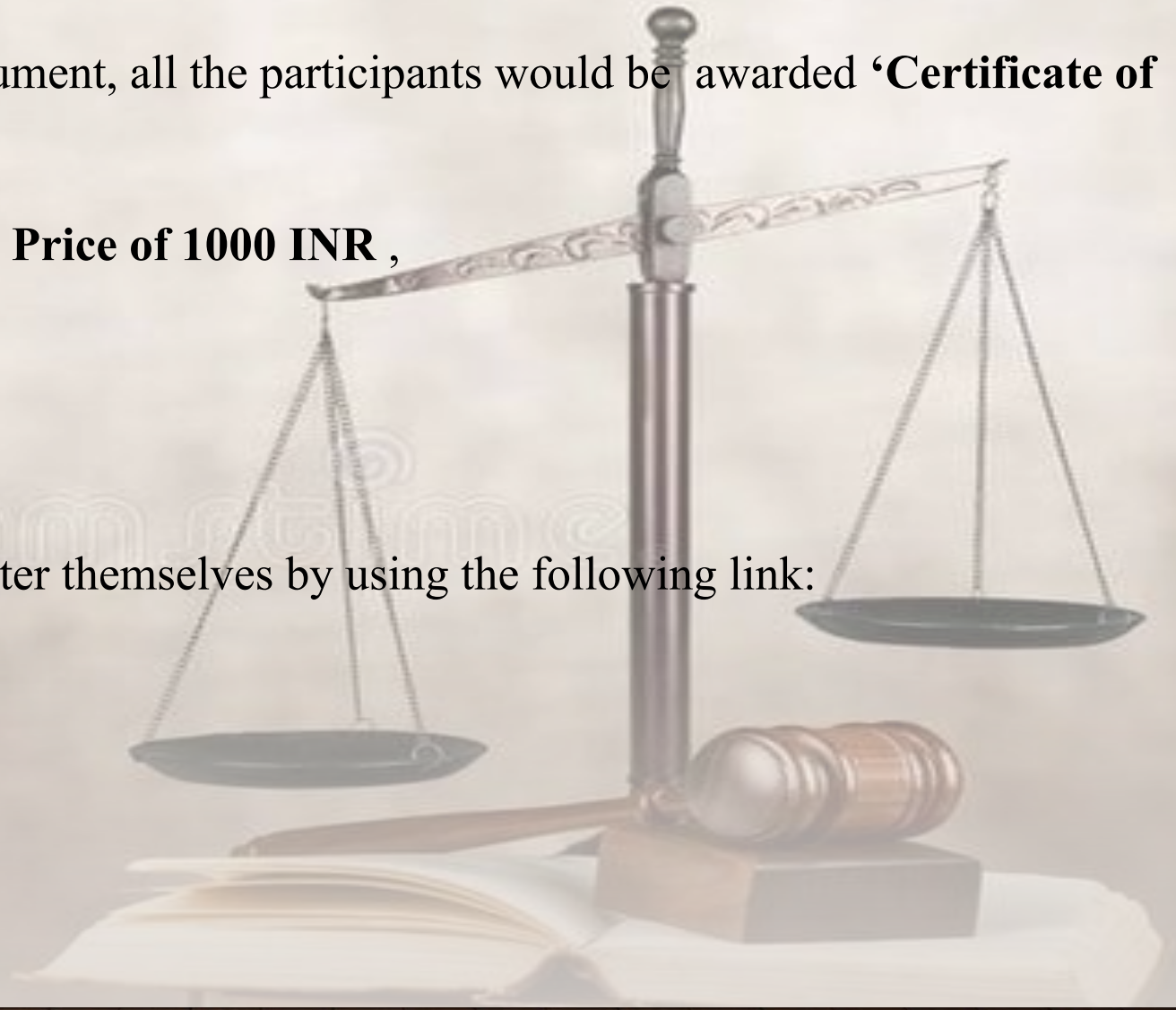

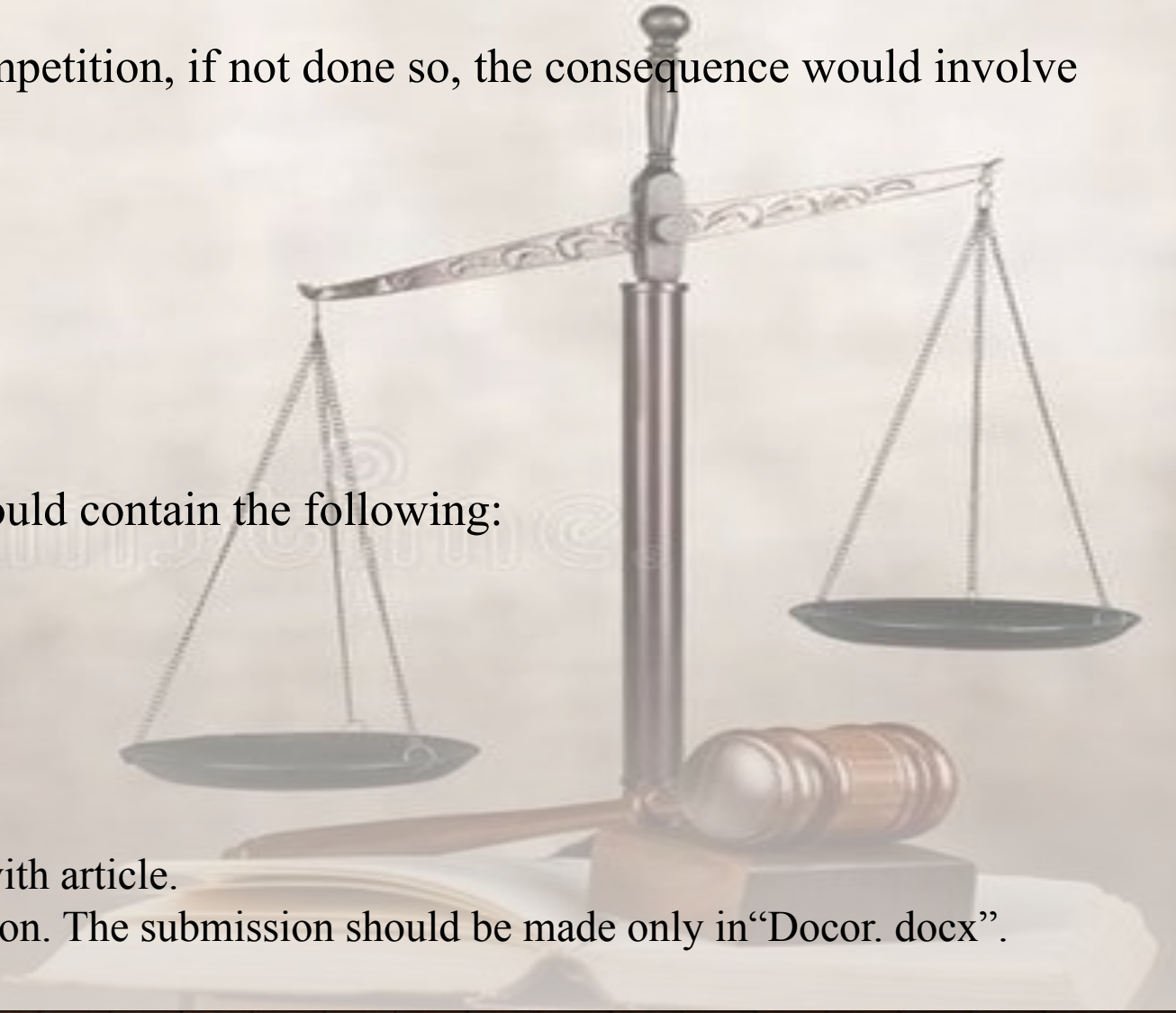
Submission Guidelines:

4. Qualification of author along with details
5. Contact number and Email ID of author.
6. Declaration has to be signed and attached along with article.
7. No participants can make more than one submission. The submission should be made only in "Docor. docx".
