Born on 18th January, 1961, Dr. Rajesh Bahuguna received his elementary education in a Government School and completed his secondary education from Government Junior High School Rajpur Road, Dehradun. Post-secondary education, he never joined any school or college to complete his further education until graduation rather completed the same as a private candidate including B. Com. from H.N.B. Garhwal University (Srinagar) Garhwal. He did his LL.B. and LL.M. both from Jai Narayan Vyas Jodhpur University. He qualified UGC- NET examination and accomplished his Ph.D. from Kurukshetra University under the supervision of Prof. R.K. Sabbarwal on the topic 'Alternative Dispute Resolution system in India.' He specializes in Constitutional Law and Alternative Dispute Resolution.

He has more than 42 years of working experience which include 15 years' service in prestigious Indian Air Force and the residue is his teaching, research as well as administrative experience. He began his career as an airman on 6th September, 1979 at the age of seventeen and half years. Subsequently, he resigned after fifteen years of glorious service as a combatant defense personnel and joined D.A.V. (P.G.) College, Dehradun as a Lecturer in Law on 11th February, 1995. He is one of the founder members of Law College Dehradun, then affiliated to H.N.B. Garhwal University and established on 1st August, 2002. He took over the position of Principal, Law College Dehradun on 1st August, 2005. When Uttarakhand University was established, he was appointed as the first Dean of Law College Dehradun faculty of Uttarakhand University and assumed charge on 24th June, 2013. He was the officiating Vice Chancellor from 9th May to 10th September, 2020 and from 30th June to 15th October, 2021. On 16th October, 2021, Prof. Rajesh Bahuguna was nominated Pro Vice Chancellor of Uttarakhand University.

A renowned face in legal academia of the state, he is a member of more than 13 top ranked institutions related to Law including Indian Law Institution (ILI) and International Centre for Alternate Dispute Resolution (ICADR). He is on the panel of more than 15 Universities and State Public Service Commissions. He is the Editor in Chief of Dehradun Law Review: A Journal of Law College Dehradun, Uttarakhand University and Law College Dehradun Newsletter. He has published 35 research papers in National and International Journals and has participated in series of events as Chair, Keynote Speaker, Guest Speaker, and Judge in Moot Courts and at times as a participant.

He is a trained mediator from International Centre for Alternative Dispute Resolution, New Delhi. Eight students have successfully completed and

presently eight students are pursuing their Ph.D. under his supervision. In addition to these, more than 35 LL.M. students have completed their dissertation under his guidance and supervision so far.
