



# **SCHOLARSHIP POLICY**

FOR SESSION 2022-23

#### A: Merit Scholarship

The Uttaranchal University encourages scholarly aptitude in students. In order to recognize their academic excellence, the following scholarships are awarded to students who perform extremely well in their qualifying examinations.

Slab	Level in which admission is taken	Award of Merit Scholarship on Tuition Fee	Percentage of marks secured in the Qualifying Examination
1.	UG/PG	30%	>=90.01%
2.	UG/PG	20%	>=80.01% to ≤90%
3.	UG/PG	10%	>=70.01% to ≤80%

## **Conditions:**

The merit scholarship will be awarded to students on the basis of their performance in their qualifying examinations if the following conditions are met.

- (I) All programmes/subjects of their qualifying examinations are cleared in the first attempt.
- (ii) This scholarship is applicable for the first year only; the students cannot claim the scholarship for subsequent years.
- (iii) There will be no rounding of CGPA or the marks in their qualifying examination, for example, if a student achieves CGPA "8.99" it will be considered as 8.99 and will not be considered as 9.00 similarly, if a student achieves 89.99% it will not be considered as 90.00%

#### **B:** Uttarakhand State Domicile Scholarship

The Uttaranchal University awards 26% scholarship on Tuition Fee to Uttarakhand Domicile Students. 40% of seats for these students are reserved for the entire programmes of the University.

To claim this scholarship, the student must carry a valid Domicile Certificate (Original) of Uttarakhand State at the time of admission/counseling.

# C: Hills States Domicile Scholarship

The Uttaranchal University awards 26% scholarship on Tuition Fee to the Domiciled students of Hill States of India viz Jammu and Kashmir, Ladakh, Sikkim, Nagaland, Assam, Tripura, Arunachal Pradesh, Manipur, Mizoram, Meghalaya, Himachal Pradesh and District Darjeeling, *Kalimpong (West Bengal)*.

# D: Sushila Devi Scholarship for Girls

The Uttaranchal University awards 5% Sushila Devi Scholarship for Girl students on net Tuition Fee. This scholarship is applicable for the entire duration of programme. The Scholarship percentage will remain same for 'Uttarakhand' / 'All India' category.

# **E:** Scholarship to the Wards of Defence Personnel

The Uttaranchal University awards 5% scholarship on net Tuition Fee to the son/daughter of defence personnel (including Para Military viz ITBP, CRPF, etc.) for the entire duration of programme.

To claim this scholarship, the student must carry a valid certificate (Original) of their father/mother at the time of admission/counseling.





# **SCHOLARSHIP POLICY**

FOR SESSION 2022-23

## 1. In case of serving Defence Personnel

- (i) Dependent's card issued to the servicemen / A certificate issued by the Unit Head / C.O. of the servicemen.
- (ii) ID card of the servicemen
- (iii) ID/Aadhaar card of the student

### 2. In case of retired Defence Personnel

- (i) Discharge certificate of the servicemen
- (ii) ID card of the Ex-Servicemen
- (iii) ID/Aadhaar card of the student

#### 3. In case of deceased Defence Personnel in combat

- (i) Dependent's card issued to the servicemen / A certificate issued by the Unit Head /C.O. of the servicemen.
- (ii) ID/Aadhaar card of the student

### F: Scholarship to the Alumni

Uttaranchal University awards 10% scholarship on net Tuition Fee to the Alumni for the first year only. To claim this scholarship, the student must carry the following documents at the time of admission/counseling.

- (i) Aadhaar / Any valid photo ID proof of the student bearing the name of the parent.
- (ii) Mark sheet/Certificate (10<sup>th</sup> onwards) issued to Sibling bearing the names of parents.

## G: Scholarship to the Sibling

Uttaranchal University awards 10% scholarship on net Tuition Fee to the Sibling for the first year only. To claim this scholarship, the student must carry the following documents at the time of admission/counseling.

- (i) Aadhaar / Any valid photo ID proof of the student bearing the name of the parent.
- (ii) Mark sheet/Certificate (10<sup>th</sup> onwards) issued to Sibling bearing the names of parents.

## H: Scholarship to the Alumnus of Uttaranchal University

The Uttaranchal University awards 10% Scholarship on net Tuition Fee to Alumnus of Uttaranchal University who are pursuing Ph.D during the academic session 2022-2023. This scholarship is applicable for first year only.

### **General Condition**

- 1. The student will not be entitled to more than one scholarship out of D, E, F and G as mentioned above. He/she may choose the best or whichever is higher and beneficial at the time of admission. Scholarship once chosen cannot be changed or interchanged with another scholarship in the future.
- 2. The award of the scholarship will be applied to the Net Tuition Fee for scholarship types D, E, F and G
- 3. The eligible students are required to submit an affidavit duly signed by their parents/legal guardians accepting all the conditions of the offer of award of scholarship.
- 4. The University shall offer the scholarship on trust that all the documents are genuine and are not forged if, at a later stage it is found that the student has obtained scholarship on the basis of forged documents/false information then, the University will have a right to recover actual fee and may also initiate administrative action as per the decision by the Management against the concerned.
- 5. The above scholarships are not applicable for University's Law programmes. The scholarships applicable for Law programmes are described separately.
- 6. The above-mentioned policies are applicable for students admitted in session 2022-2023 only.
